INSTALLATION INSTRUCTIONS for

HOBSON FREESTANDING WOODBURNER AUSTRALIA - AUGUST 2014

TESTED in compliance with AS/NZS 2918: 2001 HARDWOOD TEST No. 30A-12-0038-TRP-254693-1

- **A**. Yunca recommends that competent trades persons carry out all installations (e.g. AHHA Registered Installer), to obtain maximum performance and safe, efficient heating.
- **B**. A permit is required and we suggest you check with local building inspectors as by-laws do vary from area to area.

Also notify your Insurance Company that a solid fuel heater has been installed.

- C. Floor Protector -
 - 1. Must extend a minimum of 300mm in front of the door aperture.
 - 2. Must extend at least 100mm from each side panel of the heater.
 - 3. Ash Floor Protector must be constructed of non-combustible materials.
- **D**. Seismic restraint Heater must be restrained from seismic movement as required by AS/NZS 2918:2001. 10mm diameter bolting holes in the feet of the HOBSON allow restraint.
- E. Manufacturers' recommended tested minimum clearances from combustible walls:

F. Standard 150mm Flue Kit (Tested to AS/NZS 2918:2001 Appendix F): FIG A, B & E

1. 4.2m x 150mm stainless steel flue 3. 1 x insulation boundary shield.

2. 2.4m x 250mm galvanised liner.
3. Ceiling Plate.
4. 2 x spider brackets.
6. 1 x weather cap & cowl.

Please Note: All flue joints must be sealed with flue sealing compound. Use stainless steel screws or rivets to join the flue pipe (three equally spaced places at each joint). The first length of flue must be fixed to the flue spigot with at least one stainless steel screw or rivet. The required minimum flue termination height is 4.6 m above the floor protector.

G. HOBSON Yunca Flue Mounted Shield (Flue Guard) Kit. Complies (with heater) to AS/NZS 2918:2001): Refer FIG A


- 1 x 1200mm length lined back guard.
- 1 x 1200mm length perforated front guard
- 1 x 1200mm length tertiary back guard with spacer tabs.
- 1 x Top front deflector shield (half round shape, this is angled 30 degrees when installed).
- H. AUSTRALIAN (Flue Factory Flue Mounted Shield (Flue Guard) Kit.

Standard Triple lined flue guard kit.

Please Note: The minimum Flue Mounted Shield height is <u>1200mm</u>. HOBSON – TYPICAL INSTALLATION (Drawings not to scale)

CONDITIONS FOR FLUES (Refer Fig. E)

The FLUE shall extend to:

Not less than 600mm above the highest point on the roof if within 3.0m of that point, or

Not less than 1000mm above the intersection point with the roof and not lower than any point of the roof within 3.0m.

In any case the length of the flue shall not be less than 4.6m from the ash floor protector.

In some situations the Local Council may vary the above requirements.

- The flue system must be tested and comply with AS/NZS2918:2001, Appendix F.
- The insulation boundary shield shall be capable of preventing accidental migration of loose-fill or any combustible material by any action of wind or by persons moving in the ceiling space.







FIG D: HEATER POSITION:-

N.B. The "B" and "D" measurements on the Hobson are taken from the heater sides. "O" measurement is the width of the heater, excluding the cook top surface.





Above: Non combustible wall clearances. Brick lining from floor to within 25mm of ceiling. Leave air vents at the bottom to allow airflow in the cavity. If Yunca flue mounted shield is fitted, brickwork may be 1200mm high as long as all vertical joints in top and bottom of brickwork are left out to allow airflow when brickwork is capped.







FIG D: MINIMUM HEATER TO COMBUSTIBLE WALL CLEARANCES in mm

- D. MIXING OF APPLIANCE OR FLUE SYSTEM COMPONENTS FROM DIFFERENT SOURCES OR MODIFYING THE DIMENSIONAL SPECIFICATION OF COMPONENTS MAY RESULT IN HAZARDOUS CONDITIONS. WHERE SUCH ACTION IS CONSIDERED, THE MANUFACTURER SHOULD BE CONSULTED IN THE FIRST INSTANCE.
- E. CRACKED AND BROKEN COMPONENTS E.G. GLASS PANELS OR FIRE BRICKS, MAY RENDER THE INSTALLATION UNSAFE.

- A. DO NOT CONNECT TO AN UNVENTED HOT WATER SYSTEM
- B. INSTALL IN ACCORDANCE WITH AS 3500.4.1 OR NZS 4603 AND THE APPROPRIATE REQUIREMENTS OF THE RELEVANT BUILDING CODES.

SEISMIC RESTRAINT

Secure the heater base to the hearth or sub-framing with Dynabolts or similar through the holes provided.
